Worker

The worker is responsible for reviewing the Health and Safety objective and participating in the health and safety training in place for various jobs to help carry out our objective to reduce workplace injuries.

Communication

Training

The 2026 Health and Safety objective is part of the orientation process for all new candidates registering with NT Temps Inc. and is posted on the Virtual Job Board.

Evaluation

We will determine our improvement year over year through our records analysis and review process. The review will be kept in the Health and Safety binder for the duration of each year.

Improvement and Acknowledgement

NT Temps will measure the success of our standard through the results we obtain through our records analysis and an action plan will be put in place to identify ways to reduce workplace injuries. A review will be kept in the Health and Safety folder for the duration of each year. It will be NT Temps practice to adjust and improve the details of our standard as required.
